DSHS Reports:

2nd Narrative financial report was submitted to DSHS for January through April. 3rd quarter report will be due in June for the months of March, April, May & June.

EMS County Funds:

All EMS providers have turned in documentation for the EMS county funds with the exception of two (2) providers.

Wristband/Out of Valley Transfers:

Wristband data collecting will be mandatory effective January 2023. All hospitals and EMS need to continue reporting those numbers to the TRAC.

A self-assessment from DSHS has been emailed to Cardiac, Perinatal, Stroke, Trauma and Pre-Hospital for review. The assessment has a scoring tool that will be used to score each for compliance.

GETAC:

EMS Staffing waivers are in place until August 26, 2022, or until the declaration is lifted by the governor.

EMS Extraordinary Emergency Funds (EEFs) amount available \$810,865.00, copies were provided to the general membership.

Senate Bill 8 is currently being discussed at the RAC Chairs meetings, which will be for the EMS Education funding, those funds will be a second contract not including the current contracts.
